### **2. Applications**

- a. Applications have been delivered to all schools with the exception of Mount Vernon High School. Link Jackie offered to assist in getting applications to Mount Vernon given Link Priscilla's injury.
- b. Link Linda reported that Dr. Dorsett at New Rochelle High School suggested that there be a presentation to the Black Culture Club regarding the application process. Link Linda also spoke to the Young Achievers. If Link Linda is available she is willing to do this.
- c. Link Mary Frances noted that Dr. Foy at Woodlands should be the main contact for getting the information to the seniors. She noted that the Senior Class advisors can also be reminded.
- d. The committee discussed the need to heighten awareness of the requirement that there be 3 pieces of documentation accompanying the applications: 2 character references from someone who knows the student well (a teacher, counselor or employer) and then one letter verifying community service. **Service that is delivered through the school can be verified by a counselor, but that same counselor cannot then write the character reference.** Ideally this information would have been part of the presentation to parents, students and counselors we intended to conduct, but the assemblies have already taken place. We will look for other opportunities. In the meantime we will convey this information to the counselors at the high schools. Link Terry will ask Link Tahira if another opportunity will become available. Decision was made to keep the requirement as outlined in the application.
- e. Link Ginger is working with Link Donna to get the application on the website, available for downloading. Even though the application will be fillable, the student will still need to download, print and mail it with the supporting documentation. Once done, a new letter should be sent to the counselors informing them of the ability to download the application. That letter can also include the clarification about the letters of reference.
